Feedback analysis and Action Taken Report (2022-2024)

• Students

Based on the feedback provided by 358 students on various parameters of the syllabus and its implementation at the institution, here is an analysis of the results:

1. Continuity of the Contents in Courses Curriculum

- Strongly Agree: 28.69%
- Agree: 36.15%
- Neutral: 13.45%
- **Disagree:** 13.2%
- Strongly Disagree: 8.51%

Analysis: The majority of students (64.84%) either strongly agree or agree that the continuity of the contents in the courses' curriculum is appropriate. A smaller percentage (21.71%) disagrees or strongly disagrees, indicating that while most students find the continuity satisfactory, there is still a notable portion that stays neutral in their opinion of the continuity of the contents in courses Curriculum.

2. Depth of Curriculum Content

- Strongly Agree: 27.56%
- **Agree:** 41.95%
- Neutral: 10.45%
- **Disagree:** 13.11%
- Strongly Disagree: 6.93%

Analysis: A significant majority (69.51%) of students believe that the depth of the curriculum content is appropriate. Only 20.04% express dissatisfaction, suggesting that while the depth is generally well-received, there is room for improvement.

3. Syllabus is Industry Oriented

- Strongly Agree: 29.57%
- Agree: 43.94%
- Neutral: 13.66%
- **Disagree:** 6.58%
- Strongly Disagree: 6.25%

Analysis: The syllabus is considered industry-oriented by the majority (73.51%) of students. With only 12.83% disagreeing, it indicates strong alignment with industry requirements.

4. Objectives and Outcomes Clearly Stated

- Strongly Agree: 31.25%
- Agree: 47.89%
- Neutral: 13.56%
- **Disagree:** 11.72%
- Strongly Disagree: 7.3%

Analysis: The clarity of objectives and outcomes is well-regarded, with 79.14% of students either strongly agreeing or agreeing. A smaller portion (19.02%) feels that there is a lack of clarity.

5. Balance Between Theory and Practical

- Strongly Agree: 20.39%
- Agree: 28.36%

Analysis: The feedback indicates a more mixed response, with 48.75% of students agreeing that there is a good balance between theory and practical aspects. However, 21.6% disagree, and 29.65% remain neutral, suggesting a need for reassessment in this area.

6. Relevance of Electives to Latest Technology

- Strongly Agree: 21.36%
- Agree: 31.67%
- Neutral: 18.36%
- **Disagree:** 21.35%
- Strongly Disagree: 7.26%

Analysis: The relevance of electives to the latest technology is seen positively by 53.03% of students. However, a significant percentage (28.61%) disagrees, indicating a substantial number of students feel the

electives could be more current.

7. Curriculum Enhances Employability Skills

- Strongly Agree: 21.06%
- Agree: 26.69%
- Neutral: 24.72%
- **Disagree:** 19.68%
- Strongly Disagree: 7.85%

Analysis: Only 47.75% of students believe that the curriculum enhances employability skills, with 27.53% disagreeing and 24.72% remaining neutral. This suggests a need to focus more on employability within the curriculum.

8. Curriculum Bridges the Gap Between Industry and Academia

- Strongly Agree: 26.69%
- Agree: 25.71%
- Neutral: 17.21%
- **Disagree:** 22.12%
- Strongly Disagree: 8.25%

Analysis: Only 52.4% of students agree that the curriculum effectively bridges the gap between industry and academia, while 30.37% disagree. This indicates significant room for improvement in aligning academic content with industry needs.

9. Curriculum's Contribution to Professional Development

- Strongly Agree: 31.29%
- Agree: 41.52%
- Neutral: 10.24%
- **Disagree:** 9.48%
- Strongly Disagree: 7.47%

Analysis: The majority (72.81%) of students agree that the curriculum helps in developing professional ethics, lifelong learning skills, team building, leadership qualities, and environmental awareness. A small portion (16.95%) disagrees, suggesting that overall, the curriculum is effective in these areas.

Overall Summary

The feedback from students indicates that the curriculum is generally well-received, with high percentages of agreement in areas such as industry orientation, clarity of objectives and outcomes, and professional development. However, there are notable concerns in the balance between theory and practical content, relevance of electives, and enhancing employability skills. Addressing these areas could further improve student satisfaction and curriculum effectiveness.

The feedback provided by 18 teachers on various parameters of the syllabus and its transaction at the institution offers valuable insights. Here is a detailed analysis:

1. Learning Objectives Clarity and Appropriateness

- Strongly Agree: 26.11%
- Agree: 46.35%
- Neutral: 11.25% •
- Disagree: 8.59% •
- Strongly Disagree: 7.7%

Analysis: A significant majority (72.46%) of teachers agree that the learning objectives are clear and appropriate, indicating general satisfaction with the objectives. However, 16.29% of teachers feel that there is room for improvement, suggesting that a review of learning objectives might be beneficial.

2. Organization and Suitability of the Syllabus
