4.**Analysis of Ragging Trends and Risk Areas:** Identification of any specific locations or groups where ragging incidents are more likely & Discuss trends or recurring themes in ragging complaints.

5. **The anti-ragging Committee Squad visit** randomly to different place in the campus &Ensures immediate action is taken in case of any ragging incident. They also communicate and discuss with first year student in the campus and share information related to ant ragging and the members of committees

6. **Committee inform that the Students can report ragging incidents anonymously or openly through:**

- A Communicate with committee members
- Call to the Anti-Ragging Committee Members
- Online complaint form on the institution's website.
- Suggestion/complaint boxes placed at strategic locations.

7. **Induction of New Members to the Anti-Ragging Committee:** Dr.Pushpraj wagh welcome & Introduction of new faculty, staff, and student representatives to the committee.
