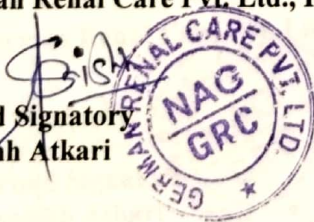

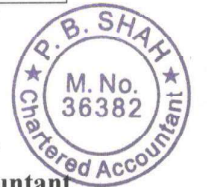

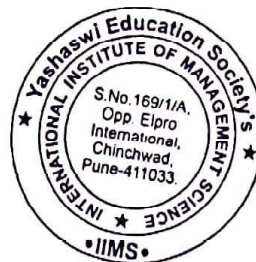

- iv. The institute from time to time will encourage and motivate the students to participate in the various social outreach programmes and extension activities organized in collaboration with the German Renal Care Private Ltd like blood donation camp, Swachh Bharat Abhiyan etc.



- v. The Institute will arrange or give opportunities to the Managers as Resource Person/Visiting Faculties at cost basis.
- 4. Obligations of the Associated Company: German Renal Care Pvt Ltd.**
- All Consultancy assignment will be undertaken in the name of the Institute. This will apply to all cases also where the client may approach an individual faculty directly.
 - German Renal Care will provide reimbursements to student interns, field trips and faculty time off to work on the research consultancy projects which will be disbursed by HMS.
 - The company will offer internship either summer or winter as well as placement opportunities to our eligible students.
 - The company will provide industrial exposure to the students through field trips/ industrial visits
 - The company will help in organizing expert talk and Discussion Forum on current trends in field of Marketing, HR and Finance etc.
 - The company will involve the students and the faculty members in the social outreach programmes and extension activities which they may undertake/conduct.
- 5. Effective Date and Duration of MOU:**
- This MOU shall be effective from the date of its approval by competent authorities at both ends.
 - The duration of the MOU shall be for a period of **5 years** from the effective date.
- 6. Resolution of Disputes:**
- Should there be a dispute relating to any aspect of academic cooperation, Director HMS, Chinchwad and Managing Director, German Renal Care Pvt .Ltd. will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.
 - This agreement shall take effect and be constructed in accordance with the Laws of India and be subject to the jurisdiction of the courts at PUNE.
- 7. Miscellaneous:**
- Through mutual agreement, the parties may organize various other value added training programmes and undertake research consultancies and collaboration.
 - Both the parties will deploy personnel to handle communications and initiatives under this MOU. The Training and Placement Officer from the Institute will be contact person.



- c. During the tenure of the MOU both IIMS and German Renal Care Pvt. Ltd. will maintain strict confidentiality and prevent disclosure of all the information and data exchanged under the scope of this MOU for any purpose other than in accordance with this MOU.
- d. Both IIMS and German Renal. Care shall not, during the term of this agreement directly or indirectly, solicit or offer employment or engagement to any of the personnel of other party without the prior consent in writing of that other party.

8. Term and Termination:

- a. This MOU shall be effective from the date of its approval by competent authorities at both ends.
- b. During its tenancy, the MOU may be extended or terminated by a prior notice of not less than one month by either party. However, termination of the MOU will not in any manner affect the interests of the students and the faculty members who have been involved in the activities under the MOU.
