

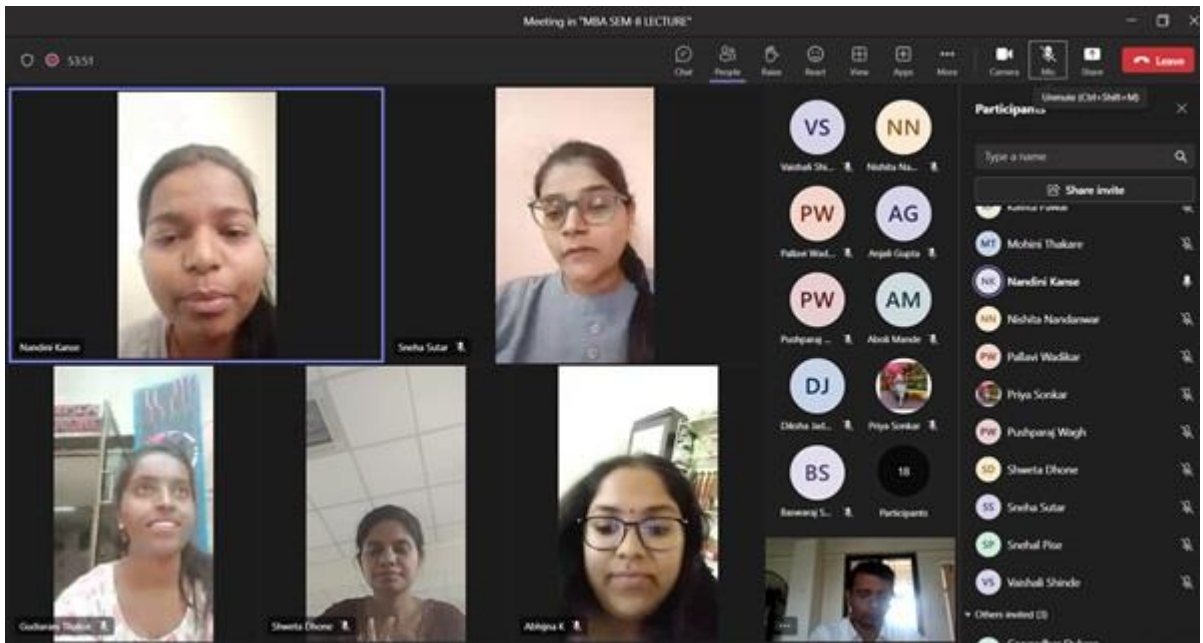



He said, the main objective of the patent is to encourage research and invention, it induces an inventor to disclose his invention instead of keeping it secret, offers reward for the expenses incurred, and provides an inducement to invest capital in new lines of production. He also shared the general precautions while filing patents and important amendments of The Patent (amendment) Act 2005.

At the end of the session, Dr. Sanjay Lakade satisfactorily answered the queries of the participants.

The attendees were from various locations of the country. There were more than 150 participants who benefitted by this impact series.

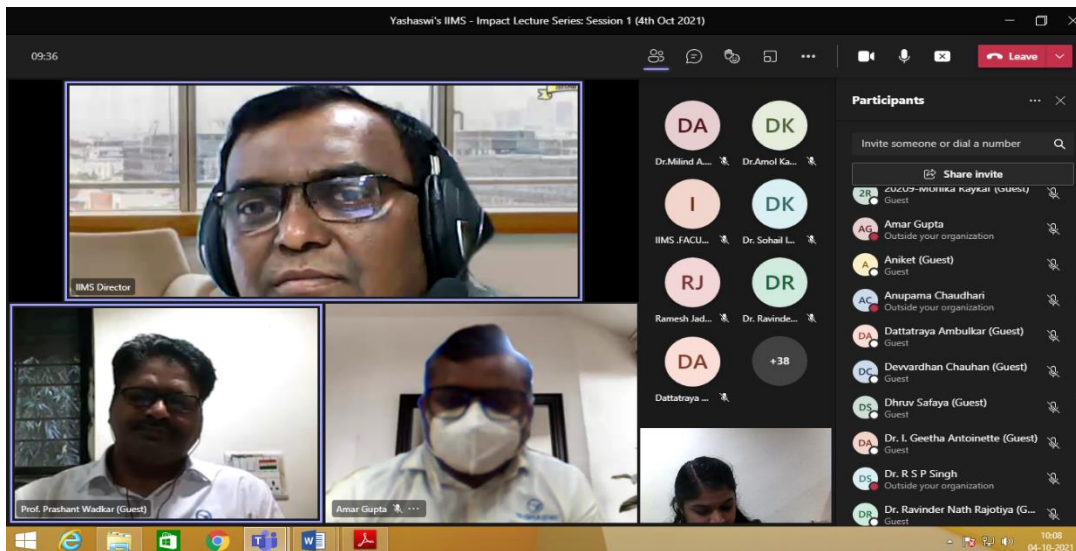

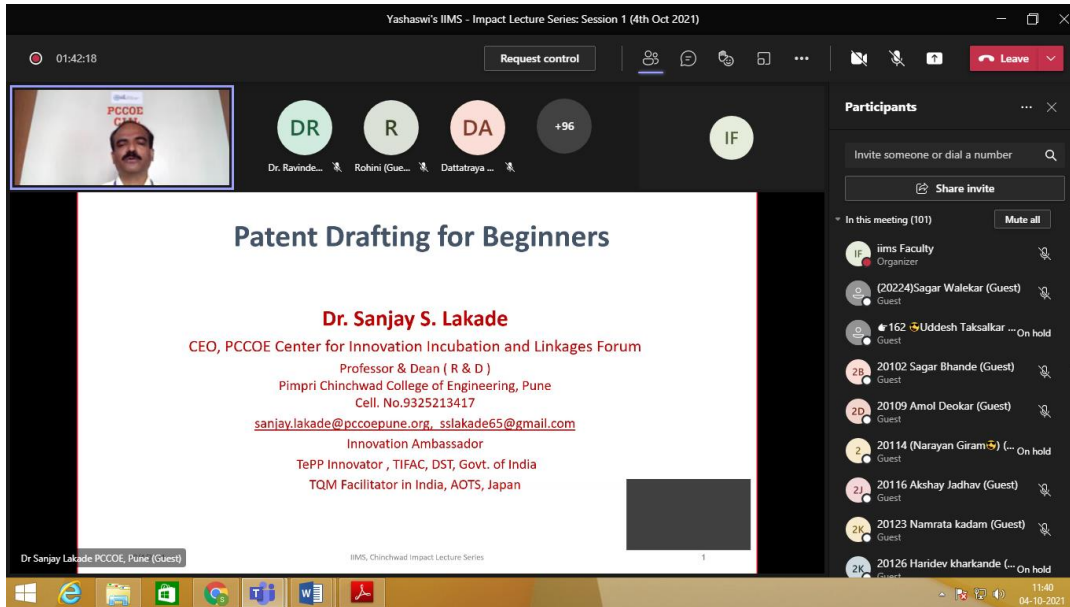

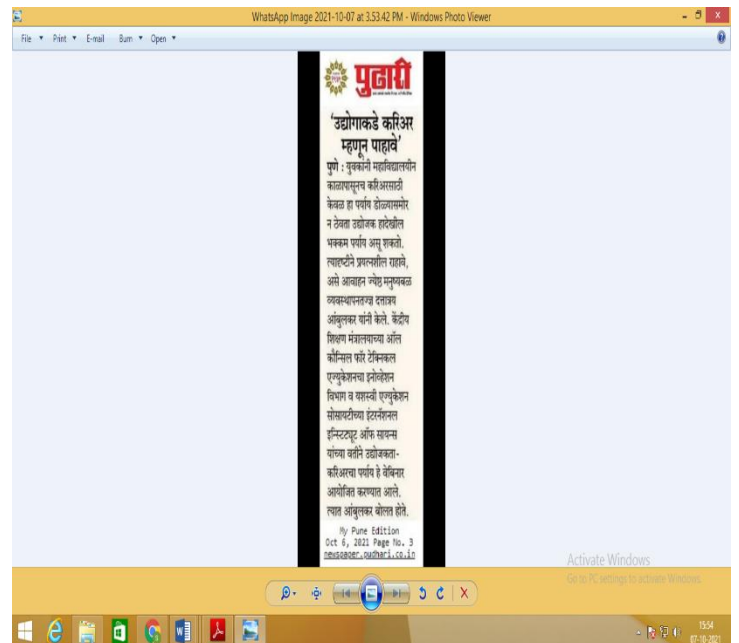
