Report of Session on Legal Aspects of Business for Entrepreneurs

Yashaswi Education Society's International Institute of Management Science organized a webinar on Legal Aspects of Business on 25th March 2022 at 11.00 am. All students of MBA, MCA, faculty members and staff were present for the webinar.

Dr. Shivaji Mundhe, Director of the Institute welcomed the Guest as well as participants on this occasion. He discussed the purpose and objective of the session that every entrepreneur should be aware of various legal requirements while starting any start-up. There are few common as well as few business specific compliances that the entrepreneur should know. The knowledge and compliance to the legal aspects is important and critical for the success and growth of a venture.

Adv. Chandrakant Shinde started the session by explaining what are the legal aspects related to business. He said that the prior knowledge of all these legal aspects is a must for an entrepreneur.

All the businesses are classified as some sort of legal entity that governs the way they are treated under the law. Few legal structures like LLC, C-Corp, S-Corp or LLP are considered as free standing entities that have special rights, for example they can enter into the contracts and the owners have limited liabilities. While other forms especially sole proprietorship, the owners have limited liabilities.


The type of legal entity you chose will depend a lot on liability profile and whether or not the entrepreneur have investors.

Various common legal aspects as well as sectorial specific legal compliances need to be identified and complied to. He gave examples of legal compliances required by telecommunication, pharmaceutical as well as automobile sector.

He interacted with the students to solve their queries and shared his experience and valuable knowledge.

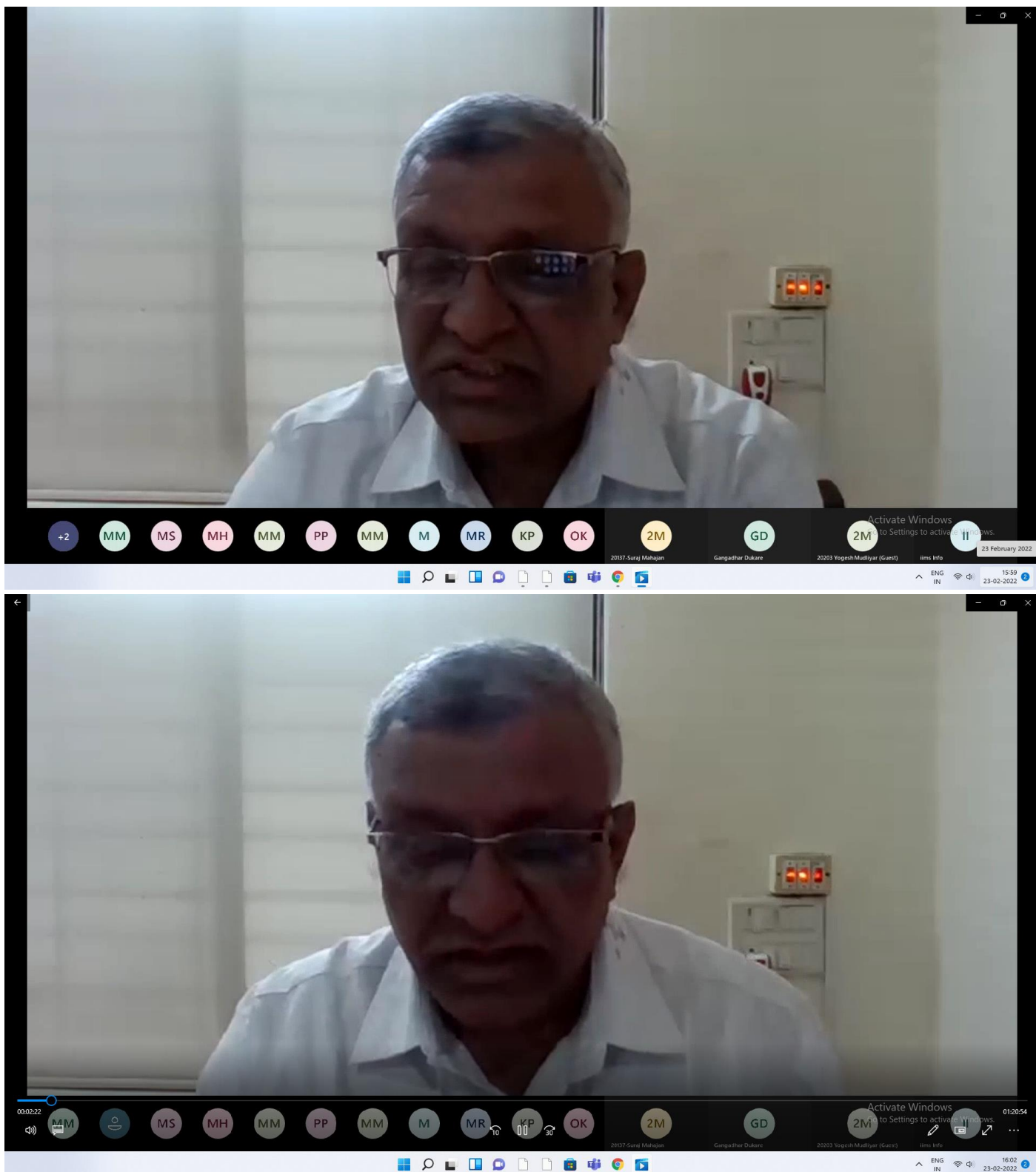
