## Report of Session on "Human Rights"

Yashaswi Education Society's International Institute of Management Science organized a webinar on Human Rights on 23<sup>rd</sup> Feb 2022 at 11.00 am. All students of MBA, MCA, faculty members and non teaching staff were present for the webinar.

Dr. Shivaji Mundhe, Director of the Institute welcomed the Guest as well as participants on this occasion. He discussed the purpose and objective of the session that every human being has been given certain rights by constitution, everyone need to know their fundamental rights and responsibilities and implications of these rights and responsibilities in his life for survival and growth.

Adv. Chandrakant Shinde started the session by explaining what human rights are. He said Human rights are rights inherent to all human beings, regardless of race, sex, nationality, ethnicity, language, religion, or any other status. Human rights include the right to life and liberty, freedom from slavery and torture, freedom of opinion and expression, the right to work and education, and many more. Everyone is entitled to these rights, without discrimination.

He discussed the classification of rights such as legal right, labors rights, farmer's rights, and constitutional rights. All they are localized rights as they differ from country to country and class to class.

He said human rights is a global concept. The human rights are given in our constitution. These rights are the basic rights and freedoms that belong to every person in the world. They can never be taken away.

The basic rights are like liberty, dignity, justice, equality, respect and independence.

He elaborated the sources of human rights. They are Universal declaration of human rights of 1948 after the Second World War, International treaties and covalence, International customs, judicial decisions and official documents.

He elaborated on the evolution of human rights and discussed the types of human rights are civil and political rights, economic and social rights, and collective rights.

He also quoted Virginia declaration 11776. This declaration specifies number of fundamental rights. It states that all men are by nature are equally free, independent and have certain inherent rights.
