

MEMORANDUM OF UNDERSTANDING

This Memorandum of understanding (MOU) is executed on 15th March 2019.
Between

- **Brahmchaitanya Superspeciality Hospital Pvt. Ltd.**
- &
- **International Institute of Management Science**

1. Brahmchaitanya Superspeciality Hospital Pvt. Ltd. would be providing services for out-patient department, In-Patient department, diagnostics Services, services for employment injuries, Health Services to the beneficiaries of International Institute of Management Science Employee & Students.
2. International Institute of Management Science Employees should carry company ID card or an authorization letter from the authorized personnel of their company or an email from the authorized personnel as applicable prior to arrival to the Hospital.
3. To avail credit facility for out / Inpatient department treatment for on-duty employment injuries/health problem (Occupational) or Non-occupational are required to produce an authorization letter duly signed by the authorized signatory or mail from authorized personnel of International Institute of Management Science.
4. Dependents of International Institute of Management Science Employees can also avail credit facility for Inpatient and Outpatient Services but they need to produce an authorization letter from the authorized signatory of International Institute of Management Science. Credit period would be for 15 days.



5. In case of emergencies beneficiaries would require to produce the letter/ Cashless Insurance card within 24 hours of the next working day from the time of admission.
6. All the hospital/diagnostic center charges shall be as per the prevailing hospital schedule of charges. Whenever there is any revision in the schedule, such revised schedule of rates shall be applicable from the date of such revision.
7. In case of credit facility bills would be submitted to the company and bill should be cleared within 15 days by cheque in the name of Brahmchaitanya Superspeciality Hospital Pvt. Ltd.
8. Credit facility would be available only in case International Institute of Management Science would be paying the bill. In case employee/student is paying directly credit facility will not be applicable but discount structure would be applicable.
9. This agreement may be terminated by either party upon giving one month notice by either parties.

4. Admin charges will be waived off for International Institute of Management Science Student, Employees & Dependents on prevailing Hospital Tariff in following criteria:


