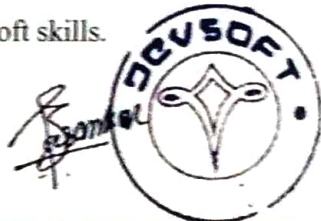

3. Obligations of the Associated Company:

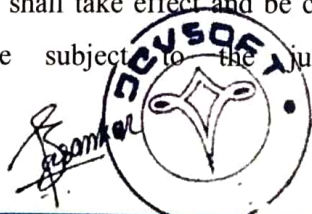
- a. The company will offer internship either summer or winter as well as placement opportunities to our eligible students.

6. Miscellaneous:

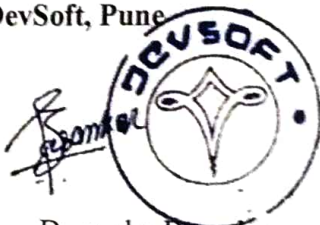
- a. Through mutual agreement, the parties may organize various other value added training programmes.
