Ms. Komal Bhutada and Ms. Vaishnavi Shinde, students of MBA introduced the guests.



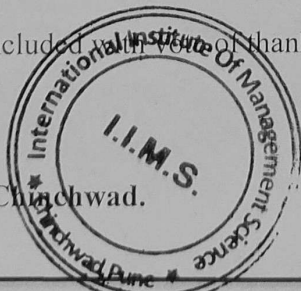
Mrs. Amruta Tendulkar discussed various examples and cases wherein the law is applicable and how the law can help preventing misbehaviour.

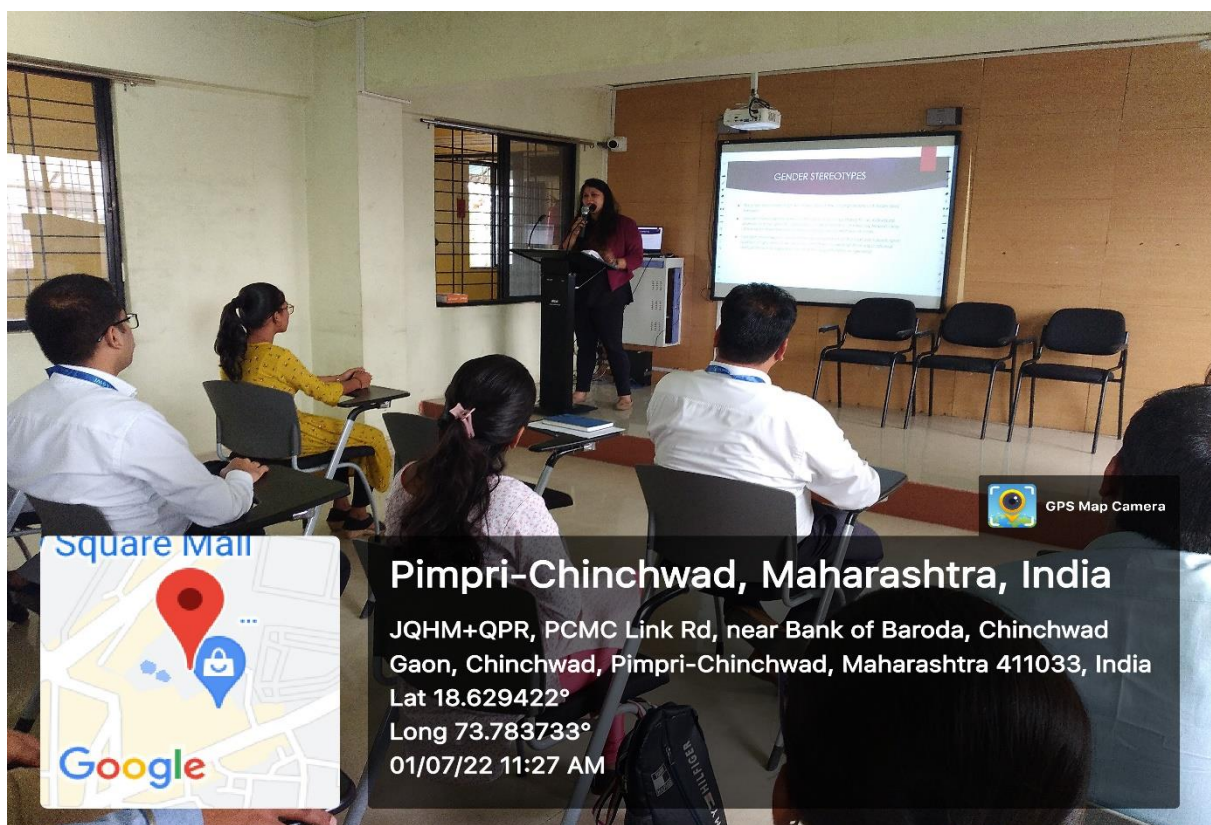
