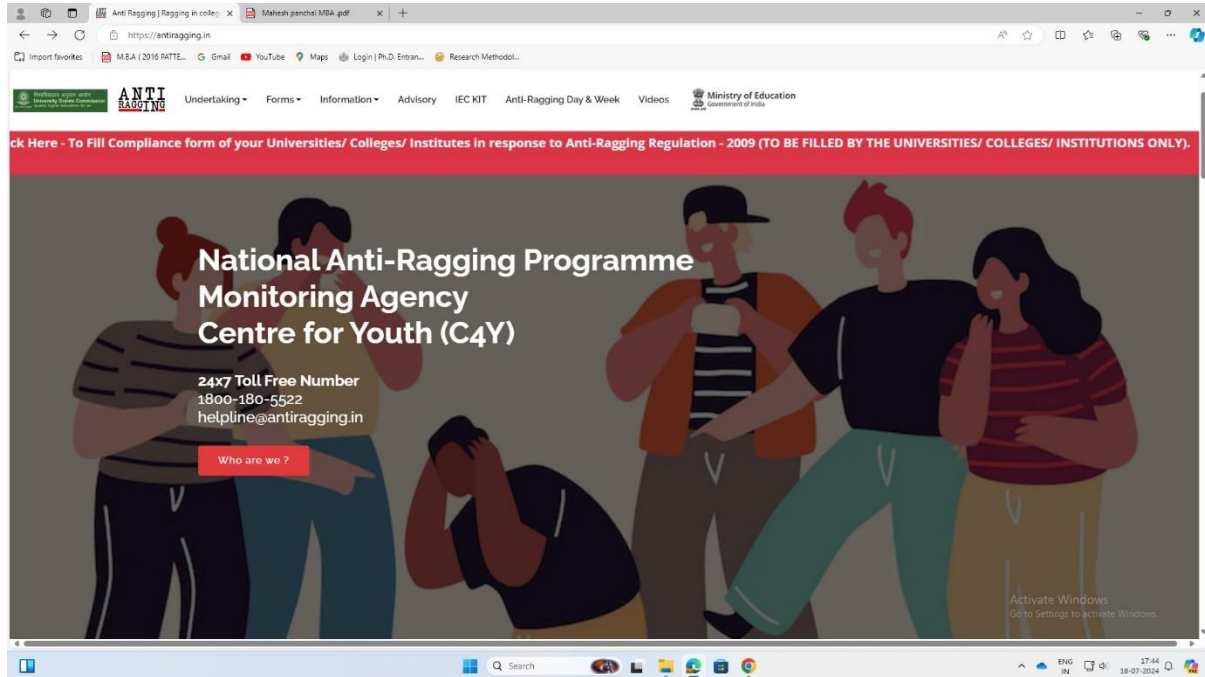
Anti-Ragging Committee:

Guidelines: In view of the directions of the Honourable Supreme Court in SLP No. 24295 of 2006 dated 16-05-2007 and in Civil Appeal number 887 of 2009, dated 08-05-2009, to prohibit, prevent and eliminate the scourge of ragging, in exercise of the powers conferred under Section 23 read with Section 10(b), (g), (p) and (q) of AICTE Act, 1987, the All India Council for Technical Education has notified Regulations for prevention and prohibition of ragging in AICTE approved Technical Institutions vide Order No 37-3/Legal/AICTE/2009 dated 01.07.2009 available on AICTE web-portal <https://www.aicte-india.org/grievance/anti>.

Internal Complaints Committee

As required by AICTE, International Institute of Management Science has constituted the Internal Complaints Committee (ICC) headed by the Director of the Institute. This is in compliance with the Ministry of Education, Govt. of India, (All India Council for Technical Education), Official Gazette Notification, Dated: 10th June, 2016, vide AICTE No.: F.AICTE/WH/2016/01, Regulations, 2016, which being statutory in nature, are binding on Technical Institutions. Even before that ensuring the safety of women and youth, and programmes for Gender sensitization on campuses across the country was earmarked and mandated as a matter of the highest priority by the government. In this direction, International Institute of Management Science has set up an ICC in August 2016. Before this, matters of this nature were dealt directly the administration through need-based committees headed by the senior most faculty members.
