The meeting of the Students' Grievances Redressal Committee started at 12.00 p.m. under the Chairmanship Dr. Shivaji Mundhe (Chairperson). The Chairperson welcomed all the committee members and introduced the student's representatives.

1. The Minutes of the meeting of the previous meeting was read and confirmed.
2. The Director briefed that the students have regularly expressed their request for regular maintenance of classroom infrastructure, shortage of water in the washrooms and improper lighting in some of the classrooms, owing to that the management has completely planned for infrastructure updation. The students grievance regarding washroom maintenance was resolved by assigning the task to Ms.Aditi Chiplunkar to monitor the cleanliness by housekeeping staff.
3. The committee briefed that all the complaints and grievances will be addressed and directed, through appropriate channels, to the concerned cell or committee which will handle the case according to its discretion. It was resolved that Ms. Nilofer Shaikh Student Counsellor of the college will orient the students on the vices of ragging and the punishments that are liable on the perpetrators as well as different dimensions of ragging like financial extortion, physical abuse and verbal abuse
4. The committee further informed that ragging in any form is strictly prohibited in and outside the institution. Any violation of ragging and disciplinary rules should be urgently brought to the notice of the Director.
5. The committee was informed that hence forth Mr Pavan Sharma will be representing from the teaching faculty and Mr Mahendra Kamble was newly inducted in to the committee as a representative from the Non Teaching Side. The committee members welcomed Mr Mahendra Kamble.
6. IQAC Coordinator Dr. Mohanty also suggested that 2 students from Second Year and 2 from First Year could be included in the committee from the next meeting so that the student representation could be part of the committee for longer time and help us to contribute more effectively

The meeting of the Students' Grievances Redressal Committee started at 12.00 p.m. under the Chairmanship Dr. Shivaji Mundhe (Chairperson). The Chairperson welcomed all the committee members and introduced the student's representatives.

1. The minutes of the previous meeting were reviewed & All action items were confirmed as completed or discussed further if outstanding.
2. The Director briefed Communication and Transparency that the effectiveness of current communication strategies with students regarding grievance status was reviewed & Strategies to enhance transparency in the redressed process were discussed.
3. The committee resolved that Ms. Nilofer Shaikh, Student Counsellor of the college, will orient the students on the vices of ragging, including different dimensions such as financial extortion, physical abuse, and verbal abuse, as well as the punishments liable on the perpetrators. It briefed that all complaints and grievances will be addressed and directed through appropriate channels to the concerned cell or committee, which will handle the case according to its discretion.
4. It seems like there were concerns raised by student representatives regarding difficulties in the registration process for NPTEL courses. The issue has been addressed by assigning the responsibility of conducting an orientation session for a smooth registration process to Prof Mahesh Mahakal.
5. Mr. Pavan Sharma emphasized the importance of maintaining classroom infrastructures, including door latches, window stoppers, fan regulators, sufficient lighting, and addressing issues like broken floor/wall tiles. The student representatives have been instructed to communicate this message to their respective batch mates.
6. Dr. Vandana Mohanty, the IQAC Coordinator, also suggested that, from the next meeting, 2 students from the Second Year and 2 from the First Year could be included in the committee. This way, student representation could be part of the committee for a longer time, enhancing our ability to contribute more effectively. The Committee bid farewell to Ms. Ravina Lodha and Mr. Nirvighna Shivbhakta and wished them a bright future ahead.

The meeting concluded with a vote of thanks to the Chair as there was no other matter to pursue.
