Ph.D. Research Advisory Committee

The minimum standards and procedure for award of Ph.D. degrees as Prescribed by UGC regulations 2009. In order to review the research proposals, finalize the topic of research and review periodically and assist in the progress of the research work, the College has constituted research advisory committee (RAC). There shall be a Research Advisory Committee for each Ph.D. scholar. Research Advisory Committee shall consist of Research Supervisor of the scholar and two subject experts of which at least one should be from outside the department. Research Supervisor shall be the Convener of this Committee

• **This Committee has the following responsibilities:**

- To review the research proposal and finalize the topic of research.
- To guide the research scholars to develop the study design and methodology of research.
- To review periodically and assist in the progress of the research work of the research scholars.
- A research scholar shall appear before the Research Advisory Committee once in six months to make a presentation of the progress of his/her work for evaluation and further guidance.
- A research scholar shall appear before the Research Advisory Committee once in six months to make a presentation of the progress of his work for evaluation and further guidance. The six monthly progress reports shall be submitted by the Research Advisory Committee to the Place of Research, with a copy to the research scholar. The Head of the Place of Research shall submit these six monthly progress reports [Appendix- 'E'] to P. G. Admission Section of the SPPU within a week from the date of such presentation.
- In case the progress of the research scholar is unsatisfactory, the Research Advisory Committee shall record the reasons for the same and suggest corrective measures. If the research scholar fails to implement these corrective measures, the Research Advisory Committee may recommend to the Research Centre with specific reasons for cancellation

of the registration of the research scholar.

 - Topic Presentation
 - Conceptual Presentation
 - Review Of Literature
 - Questionnaire & Pilot Study
 - Empirical Study & Data Analysis
 - Pre Ph.D. Presentation
- The Researcher has to apply topic wise plagiarism Check
- Every research scholar should complete the courses work of 16 credits within a one year from the date of admission.
- The component of the course work is as follows”
 - Part1: Research methodology **4 credits**
 - Part2: Write of research proposal for obtaining **4 credits**
 - Financial assistance from the national
 - Funding agencies
 - Part3:Subject specific advance level courses **8 credits**
- The course work completion should be submitted at the research canter before pre PhD presentation.
- Every research scholar has to mandatory publish minimum two research papers on their research area along with research guide in UGC care/WOS/SCOPUS/ABDC journals before each six monthly presentation
- Ph.D. programme shall be of a minimum duration of three years, including course work and a maximum of six years.
